Compliant to the requirements set out in Art. 3 of Commission Regulation (EU) No. 1935/2004 of 27. October 2004 on materials and articles intended to come into contact with food and repealing Directives 80/590/EEC and 89/109/EEC, the material(s) used in these products are chosen for their technical quality as well as purity suitable for contact with foodstuffs. Current amended version with 2019/1381 (20 June 2019) is included.

The products listed above are manufactured pursuant to the requirements outlined in European legislation regarding labelling and traceability.

EU Commission:

In accordance with EU Commission Regulation no. 1935/2004 this product is intended for food contact. Therefore it can be marked with the "glass & fork" symbol either on the packaging or through labelling.

Products are manufactured according to EU Commission Regulation no. 2023/2006 on good manufacturing practices for materials and articles intended to come into contact with food (GMP).

Overall migration tests are made on similar products. The products meet the requirements regarding overall migration testing to 10% ethanol, 3% acetic acid, 95% ethanol at 40 °C for 10 days. According to (EU) No. 10/2011, the materials with contact to food may not release more than 10mg/dm² of substances under the course of testing.

The tested samples comply with these requirements.

Specific migration of metals. In compliance with the requirements of Annex II, (1) of the (EU) No. 10/2011 the product sample did not release any excess of heavy metals when subjected to a 3% acetic acid testing, at 40 °C for 10 days.

Migration of Primary Aromatic Amines - In compliance with the requirements of Annex II, (2) this product was not found to release any primary aromatic amines in detectable quantities following a standard testing in 3 % of acetic acid for a period of 10 days at 40 °C.

Min. temp: -18 °C, usable at -8 °C. Repeated use in freezer might accelerate product wear.
Max. temp: 40 °C
Suitable for: All foodstuffs and drinks.

Max. Wash temp.: Dishwasher-safe.
